Dr. Passalacqua presented the Board information about school district budgets and the Local Control Funding Formula (LCFF). He began with a general breakdown of the thousands of accounts in the District, how the budget is comprised, the process and role of outside agencies, types of revenues, budget acronyms, and the process the District goes through each year with the budget reports before, during, and after State projections and assumptions. He stressed that, due to the Board’s long history of being fiscally conservative and the renewed projections coming from the State, the District looks to continue to be in good shape.
